Saturday, February 28th, 2026

WHERE:

UNH, Hamel Rec Center, 5 Edgewood Rd, Durham, NH (use Lot H ground-level entrance, more info next page)

ELIGIBILITY:

Anyone currently registered with any of the national governing bodies USJA, USA Judo, Judo Canada, USJF, or ATJA may enter the tournament. Collegiate competitors must present **proof of enrollment** per NCJA standards. NCJA membership not required. See ncajudo.org for info. Regional referee certification offered.

RULES:

Round robin for divisions of 3&4, single elimination in Grand Champion, true double elimination for all others. Modified 2025 IJF rules to include: **no chokes** up to Intermediate; **no armlocks in Novice** Cadet, IJF Junior, Collegiate, or Senior & all age categories under 15; **Elite Cadet, IJF Junior, Collegiate, or Senior / Ne Waza / Veterans** under 60 chokes and armlocks permitted regardless of competitors' ages and ranks; **no chokes** in Veterans 60+ but armlocks allowed regardless of competitors' ranks. Golden Score time limited where indicated. Any required rest periods within the same division will be at least 1 full regulation match time. Ne Waza follows standard IJF rules with extended time for progress. Coaching from designated mat-side coach box permitted during match. **All Elite Cadet, IJF Junior, Collegiate, or Senior divisions & Grand Champion require white and blue judogi.** In other divisions blue competitor may optionally wear white gi with blue belt. Any additional modifications decided by tournament director and chief referee subject to tournament day conditions.

Cadet, IJF Junior, Collegiate & Senior Elite categories –	4 minutes


DIRECTIONS:

From Route 95 N/S: Take exit 4 (on 95 North) or 5 (on 95 South) onto Route 16 North, Spaulding Turnpike. Take exit 6W (Route 4 West) heading toward Concord. After passing the exit for Route 108, there will be a traffic light at Madbury Rd. Take a left onto Madbury Rd, then right onto Edgewood Road. On the corner of Edgewood and Main St is the Hamel Rec Center.

From Route 101: Take exit 7 onto Route 125 and head north. Take the first right onto Route 4 East at the traffic circle in Lee. At the traffic light, take a right onto Madbury Rd, then another right onto Edgewood Road. On the corner of Edgewood and Main St. is the Hamel Rec Center.

From Route 4 East: Go halfway around the traffic circle in Lee, staying on Route 4 east, then follow directions above for Rt. 101.

From Route 4 West: Follow last part of directions for Route 95

In consideration of being permitted to participate in any way, including travel to and from, in any Judo tournament, practice, clinic, and related events and activities ("Activity") of the **United States Judo Association, United States Judo Federation, Inc., USA Judo, Seacoast Budo LLC, American Traditional Jujutsu Association, New Hampshire Judo Inc., University of New Hampshire and University of New Hampshire Judo Club**,

I agree:

1. I understand the nature of Judo activities and believe I am qualified to participate in such Activity. I also understand the rules governing the sport of Judo.
2. I further acknowledge that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. I acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, illness or disease, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, illness, disease, permanent disability, or death.
5.
